MSW TRAINED PROGRAM MANAGERS CONDUCT IN-DEPTH PSYCHOSOCIAL INTERVIEWS WITH FAMILIES, MATCH YOUTH WITH SCREENED AND TRAINED SAME-GENDER VOLUNTEERS, AND PROVIDE PROFESSIONAL SUPERVISION TO EACH RELATIONSHIP, WHICH MEETS FOR 3-4 HOURS, TWICE A MONTH, ENGAGING IN RECREATIONAL, CULTURAL, ACADEMIC ACTIVITIES IN THE COMMUNITY. IN 2022, WE SERVED 698 YOUTH AND FAMILY MEMBERS INCLUDING NEARLY 200 IN ONE TO ONE MENTORING RELATIONSHIPS WITH A VOLUNTEER MENTOR. PROGRAM TEAM CONTINUED TO PROVIDE FAMILY EMERGENCY SUPPORT AND SUSTAIN MATCHES. PROGRAM MANAGERS CONDUCTED ONGOING NEEDS ASSESSMENTS FOR OUR FAMILIES AND PURCHASED ESSENTIALS FOR FAMILIES THAT NEEDED ASSISTANCE.
